We would like to invite you to participate in the upcoming WA State Trauma Conference. The event will be held at the 5-star Westin Hotel, 480 Hay Street, Perth.

The WA State Trauma Conference has been a very successful multidisciplinary educational activity for the trauma care providers in Western Australia and is the only significant Trauma conference of its kind in the state. Historically, the event has attracted approximately 220 participants each year, including people from WA country regions and interstate.

The 2022 conference will commence with workshops on the afternoon of Friday 25 November, followed by a one and a half days conference on Saturday 26 and Sunday 27 November. This multidisciplinary event will provide an insightful overview of current trauma prevention strategies, pre-hospital and acute management, and the future focus. The Organising and Scientific Committees are working hard to build a program that will attract an even blend of medical practitioners, allied health professionals, researchers both established and emerging, nurses, paramedics and injury prevention experts.

The programme has been expanded to include an injury prevention stream creating three concurrent sessions. Whilst most of the scientific programme concentrates on new practices and innovations within trauma care, there is a renewed focus on the importance of looking after the providers of this care. Practitioner self-care will be highlighted within the programme both in a pre-hospital and acute setting. In addition to this we aim to encourage innovation and research by providing a session dedicated to free papers and the opportunity to display posters.



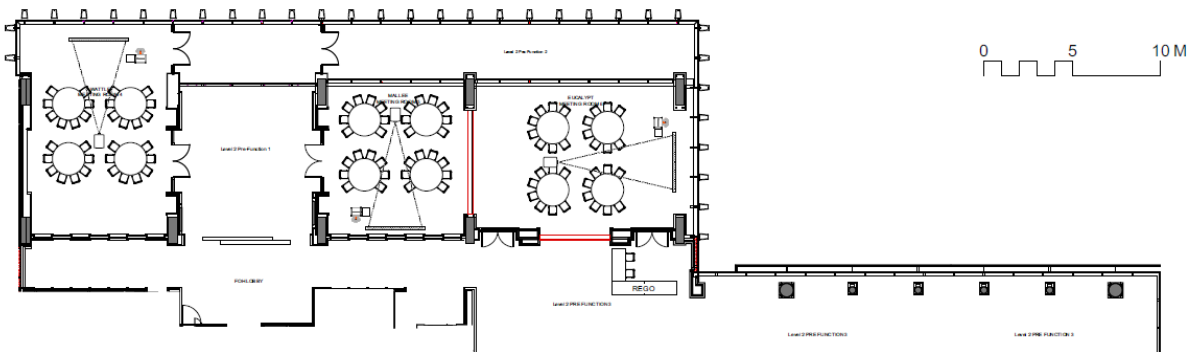

# Exhibition floor plans

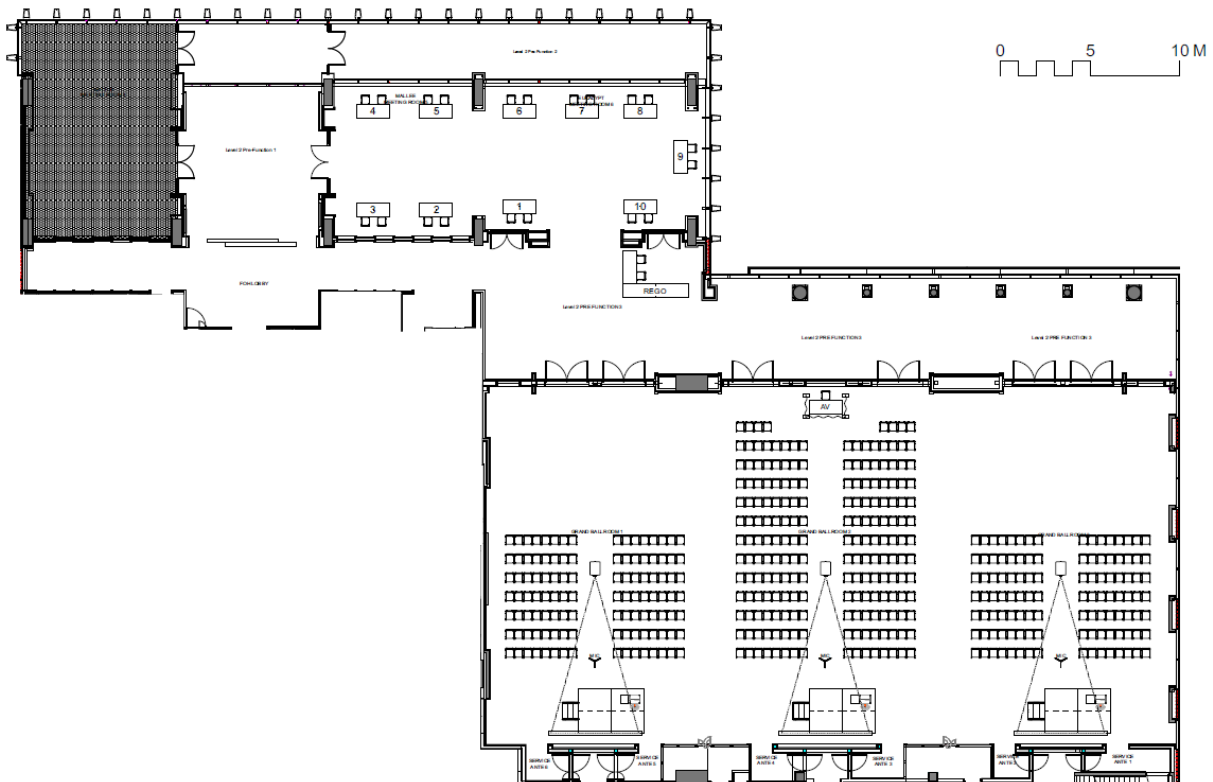

## Terms and Conditions – WA State Trauma Conference Exhibitor

1. For the purpose of this contract, the term Organiser shall include the WA State Trauma Conference Organising Committee.
2. The Organiser agrees to provide the Exhibitor with the agreed inclusions as described in the WA State Trauma Conference 2022 Sponsor Prospectus. Any additional needs of costs will be at the Exhibitor's expense.
3. The Exhibitor agrees to strictly abide by the schedule of payment as outlined by the Organiser.
4. The Organiser reserves the right, to change the dates of the Conference and shall not be liable for any losses incurred by reason of any such change. In the event that the exhibit space should be in any way rendered unusable, this contract shall not be binding.
5. This contract may be cancelled by either party provided written notice is received no later than close of business, Friday 30 September 2022; The Exhibitor will be refunded 75% of the agreed contract with 25% retained as service fee. Cancellations after this date will not be entitled to a refund.
6. The Exhibition must be assembled by the start of the conference. Space that is not occupied by the start of the conference may be reassigned by the Organiser for other purposes. Furthermore, the Exhibitor agrees that no display may be dismantled and must remain intact until the closing hour of the last day of the conference, without prior arrangement.
